You will be consulted about individual projects before they start; for example through a residents' meeting, through the Leaseholder Forum, by letter, newsletter and/or the Internet. We will seek and take your comments into account wherever possible. A named officer will be a point of contact for each project and will be available to provide you with updated information throughout the course of the project.

As in previous years, our programme is targeted towards the maintenance of the Government's Decent Homes Standard. A large proportion of the programme is committed to the renewal of individual elements as and when they reach the end of their useful lives.

You will also see addresses that are due for attention under the cyclical decorations programme (external and internal communal areas). The final programme will depend on the results of inspections currently being undertaken, and there may, therefore, be some change to this list of addresses.

We are also embarking on the first phase of Decent Estates improvements and will shortly be proposing solutions to the problems already identified by residents on those estates.

The first round of consultation has been completed and we will shortly be visiting residents again to propose solutions and get their views. In this way we will ensure that the final schemes are determined by resident priorities.

Area Renewal Projects

The Council has been successful in applying for Government support for three Area Renewal Schemes. The projects at Beavers Estate and Clements Court, the Heston area and Manor Lane, will provide new family housing, regeneration and extensive improvements for local residents. Consultation meetings with residents will begin in the next few months.

If your home is included in the programme, you will be contacted and consulted before any works are carried out to your property. In the first instance you should not normally be visited by anyone other than a tenant liaison officer from Hounslow Homes. All Hounslow Homes employees and contractors carry ID cards with their names and photographs.

Should anyone visit you at home, you should ask to see his or her ID card. If you are in any doubt, ask the caller to wait outside whiled to call us to verify their identity.

Do not let anyone into your home unless you are sure of his or her identity.
